Subject: Conspiracy, Misconduct & Obstruction Of Justice by Deputy District Attorney David Lattuca & Officers Of The Oceanside Police Department.

District Attorney Dumanis, Chief Deputy District Attorney Korsmeyer, Acting Chief Of Police Grigsby,

I am in receipt of Ms. Korsmeyer letter dated 5-15-08 and Acting Chief Grigsby's letter of 4-24-08, and I am not at all surprised that the DA's office and the Oceanside Police Department would want this issue to quietly go away. You have ignored and covered up misconduct complaints in violation of department polices and procedures, not to mention felony criminal violations of the penal code, and I can guarantee you, it is not going to go away quietly. I take it personal when police officers and district attorneys commit criminal conduct against my family, and then tell me to go away with self-serving assurances that appropriate action has been taken, which I cannot verify or check on. You obstruct filing and investigation of criminal complaints, cover up and ignore misconduct complaints, and lie badly about investigations that never occurred, in order to cover up criminal conduct by assistant District Attorneys and Police Officers, and you really expect me to trust you.

I am sure it is more than uncomfortable to find out that someone noticed that an Assistant District Attorney and police officers are involved in misconduct and felony obstruction of justice. I will tell you what I told Wawanesa Insurance. If you are going to commit felony crimes, you should not put it in writing above your name. An Assistant District Attorney is an officer of the court. To state in writing that his insurance fraud investigation division, in the DA's office, will not accept or investigate felony criminal complaints from citizens, against insurance companies, or their employees, because you are too busy and don't have enough staff, is criminal obstruction of justice. If that is not bad enough, to further state that the motive for this criminal conduct is the protection of special funding grants to Mr. Lattuca's Insurance Fraud Division was really dumb. Mr.

Lattuca and the District Attorneys office is illegally locking citizens out of guaranteed legal protections that the same fraud division is actively providing to insurance companies on a daily basic. That is biased, illegal, and criminal conduct for a District Attorney or a police officer.

The entire time that the DA's office was criminally obstructing complaints against insurance companies, it was pushing citizens to file a complaint with the California Department of Insurance. This was being done with the knowledge that the special funding that Mr. Lattuca's insurance fraud division is protecting, comes from the CDI, and that even the CDI insurance fraud investigation offices are also exclusively geared to investigate consumers, and protect insurance companies, which is also criminal conduct.

The District Attorney's Office has also passed on this policy of criminal obstruction to police departments, which is why Mr. Lattuca sent me there, and why the Oceanside Police Department obstructed the filing and investigation of the same criminal complaint, and then covered up the subsequent misconduct complaints to protect officers just as the DA's office did. The DA's office points the finger at the police, and the police point the finger at the DA. How convenient, I can only assume that is the fall back plan when a citizen will not passively accept an illegal no, from the DA or the police.

I will do everything legally possible to get criminal complaints filed against Mr. Lattuca, and appropriate Oceanside Police Officers, with any available local, state or federal law enforcement agency. Mr. Lattuca's letter, documenting criminal conduct, will be most helpful. When filing, I will take tape recorders, and whatever media professionals are available as witness, to insure that law enforcement conforms to the law. I will set up web sites, mass e-mail warning, newspaper ad warning, TV exposure, etc., to warn San Diego citizens of this obstruction of justice and criminal conspiracy by the DA and Police to aid and abet the fraud of citizens, by insurance companies.

If you are going to get into bed with the insurance companies, you should also get prepared for the civil liability that goes with it. When you force citizens into the civil courts to address criminal conduct by insurance companies, then the DA, Police Departments, and all involved individuals should be named as defendants, right next to the insurance companies. I will post all documentation on the Internet for citizens and their attorneys, and actively notify every attorney that I have worked with for the past 30 years.

As a former police officer, I apparently take my 40-year-old oath, to protect and serve, more seriously that you do, and I also arrest on sight individuals committing felony criminal conduct.
