Agent Aguirre,

As per our discussion the city council video recording containing the statements from Chief Of Police McCoy, that Officer Damon Smith has not done anything illegal, is at the below link on the city council web site. My 3 minute allowable presentation starts in "Play 5 Part 2" from the pull down menu for date 8-12-09, which is followed by a rebuttal from the Chief of Police. A rebuttal that had obviously been planned in advance by Mayor Wood. Apparently my precious public complaints were shaking somebody's cage.

The video also contains a response from Councilmember Sanchez about an earlier meeting she request to try and convince me to stop talking about police corruption. Both Mayor Wood (31 year OPD retired officer) and Councilmember Sanchez (Public Defender Sanchez) were present and said nothing when Chief Frank McCoy stated there was nothing illegal about police recording conversations, but he omitted the facts that the recording were made by a on duty police officer, actively engaged in investigations with an 8 year history of tapes, which by intent were hidden from the DA and the Criminal Justice System.

Agent Aguirre,

I have new info that confirms a cover up is underway in the DA's investigation of the evidence tampering by Officer Damon Smith & other Oceanside Police Officers.

On Oct. 6, I interviewed Andrew Limberg, the attorney that discovered the secret evidence taping back in late April. After Officer Smith left the stand he contacted Limberg over his concerns about how much trouble he was in. Officer Smith stated to Attorney Limberg that it was "common knowledge" among the police officers that Officer Smith worked with, that Smith was secretly recording investigations for eight years.

Question: How many Oceanside police officers is covered by the statement "common knowledge"?

Question: How many other Oceanside police officers were also secretly recording investigations?

Question: Why has ADA Laura Gunn suppressed the witness information that would substantially expand the number of corrupted cases and destroy the cover up of illegal police evidence tampering?

The above witness information was given to ADA Laura Gunn (head of the DA's investigation in Special Operations) on October 9. As of last Friday the 23rd, no one from the DA's office has contacted Mr. Limberg, nor did any DA's investigators contacted Mr. Limberg during the original investigation that has been underway for over 5 months.

On Oct 22nd Paul Levikow of the DA's office went on the record in the North County Times stating Officer Damon Smith had not committed any crimes and was not going to be charged. Only 35 tapes have been released to defense attorneys. Cases that Damon Smith worked on where no tapes were recovered are apparently not even being considered.

The DA's office knows that other Oceanside police officers knew about the secret evidence recording over an extended period of time and kept their mouths shut. They also know that if Damon Smith is arrested or indicted he will start talking about the identity of those officers and this cover up will explode in the District Attorneys face. The failure of this cover up would directly impact the positions of DA Dumanis, Oceanside Chief of Police McCoy, Oceanside Mayor Wood, and Councilmember Sanchez, all of which are on the record stating that Officer Smith's evidence tampering is not illegal, while they block all demands for full investigations.

The cover up of the evidence tampering by Oceanside police officers is also connected to protecting active police & fire union contract negotiations, and a covert union recall campaign against the swing vote on the Oceanside city council necessary for a new contract in January 2010.

This is not the first time that the DA's office has protected Oceanside police officers from citizen criminal complaints and investigation of those complaints, to protect ten's of millions of dollars in special funding grants, and to avoid civil liability.

I will follow up today or tomorrow. If I can provide any additional information, please do not hesitate to contact me.

Mr. Mosler,

The AG's office was contacted at the same time I contacted the DA's office, based on your recommendation. As soon as the AG's office heard it involved DA and Police criminal conduct, he did not even want to hear about it, much less review any evidence. A two sentence letter was received even before he had all the documentation. The cover up started even before he saw any documentation. You're the DA, and criminal conduct by anyone including DA's and Police is your responsibility, and it is two attorneys on your DA staff, not one.

You have also said nothing about the criminal conduct by Oceanside Police personnel, which are definitely with your responsibility. You have been given detailed info with name and address of a witness to the involvement of multiple Oceanside police officers in the Officer Damon Smith Evidence tampering as well as the fire and police union conspiracy to tamper with and election, including falsification of public records. The FPPC has issued warning letters, and advised that only the DA can take criminal action.

So are you going to bury all of this because they wear badges or work in your office. You knew exactly what the AG's office would do when you gave me his name. I expect your office to investigate and prosecute all violations. That is what your are paid to do.

Agent Aguirre,

This morning I filed a felony criminal conspiracy and assault complaint (copy attached) under Oceanside Police Department #10003712. I found witnesses to the involvement of multiple Oceanside police officers in the Officer Damon Smith Evidence Tampering. I gave that witness info to the Oceanside Police Dept. and to ADA Laura Gunn, supervising ADA of the District Attorney's office. Neither group ever followed up with the witness, the attorney that discovered the original tampering. The DA's office then transferred 35 audio tapes on corrupted criminal cases to the Public Defenders Office and closed the investigation with no action against Officer Damon Smith. I filed a criminal complaint with DDA Damon Mosler against ADA Laura Gunn and others for evidence tampering and Obstruction of justice. The complaint was buried by the DA's Special Investigation Unit and the San Diego Attorney Generals Office.

On 2-24-10, I was filing a public complaint in the city council meeting regarding police and council criminal corruption on the Evidence Tampering Cover Up, protected by the Brown Act. The Mayor then ordered 3 police officers to remove me from the chamber against my will. This was a preplanned assault, a conspiracy by Mayor Jim Wood and 3 Oceanside Police Officers, and as usual the DA's office does not want to hear about it and it is documented on video.

The FPPC also came down with warning letters on the falsification of public records (campaign finance records) recently, confirming that two committees and multiple police and fire department supports were falsifying records to hide the money source in the Kern Recall Election (documentation attached). Complaints about this Election tampering to city council and Oceanside police were ignored, while they criminally pursued other citizens with less serious violations that were kern supporters. I also filed a criminal complaint with the Oceanside Police this AM. I will forward case number as soon as I get it.

Agent Aguirre, I have a retired OPD cop Mayor ordering police assaults on citizens that complain about the corruption in city council meetings, and I am not the first one. Please reply to confirm receipt.

I got this e-mail about 2 hours after our conversation. This gentleman almost went to prison on an assault with a deadly weapons charge because the Oceanside Police and the DA's office were hiding an audio tape that could clear him for a year while he was pressed to confess for a lighter sentence. Then suddenly the audio tape appears on the day of trial and the DA tries to suppress it. He says he will talk to anyone.

The judge in my case was completely outraged at the D.A., and she still tried to bury the audio statement at Oceanside Police Department the day of my car accident. The judge overruled her motion, and my attorney asked for a side bar while I was testifying. The judge (Manio/Vista/departament 26) came back and said "we'll break for 20 mins". After the jury left, he scolded the D.A., and asked her why the audio statement was just disclosed the day of trial. She claimed that she "read the police officer the riot act" and she was not aware of the audio statement until the day of trial. My audio statement was crucial evidence that proved I was innocent! After the jury heard that recorded statement, they deliberated for 30 mins, and came back 12-0, not guilty! I've been married for 8 years, licensed broker, honor student on my way to UCSD. I almost took a plea to avoid a very scary prison sentence. I stuck to my guns because I knew I was not guilty, against the advice of my parents, and attorney. They all said the risk is too great, but I knew I was innocent. I was arrested on 2/25/09, and I was acquitted of all charges just two days ago. For over one year the Oceanside Police Department buried my recorded audio statement, and denied that I ever gave one. Thank God, my attorney found it the day of trial. If I would have plead guilty, the Oceanside Police Department would have completely gotten away with this. I have spend \$17,000 of my UCSD college money on legal fees, private investigators, and CHP accident reconstruction specialists to prove my innocence. I should be in a class room at UCSD right now, instead I'm working two jobs to replenish my savings and make ends meet. I almost lost my marriage, and thought about suicide everyday. I even thought about taking off to Costa Rica and living my life as a fugitive, but I thought about my family here, and I couldn't do that to them. Needless to say I was shocked when I came across your article from 10/09, almost eight months after my arrest. After reading your article, I ran to the bathroom and threw up. I wonder how many people are in prison, or took a plea deal because of this. This is a huge story that needs to be told.

Agent Aguirre,

Attached is copies of the documentation on a criminal complaint and misconduct complaint I filed this week with the Oceanside Police Department regarding more police and DA's tampering with evidence in criminal prosecutions, and this time an innocent man almost went to prison. A copy of the e-mail I received from Mr. Shields is attached. An innocent man and his family were almost destroyed by an extensive conspiracy of mutual cover up and protection between dirty cops, dirty DA's, and dirty politicians, and Mr. Shields is not the only victim.

This was one evidence tape recording, in one case that we know of, by Officer Dominique of the OPD. Officer Smith was recording criminal investigations and hiding the tapes for eight (8) years.

Da's that are caught with too much evidence are being quietly discharged with no criminal investigations, no arrest, no prosecution, and no comment. All criminal complaints filed by myself, with the Oceanside Police, San Diego County District Attorney, and the San Diego Attorney General's office have been buried. Not one investigator, from any of these agencies, has followed up with me, on any investigation of the complaints that have been filed. As of this week, according to OPD Internal Affairs, not one of the multiple police misconduct complaints with hard evidence of police corruption, has been assigned out for criminal investigation.

I will send hard copies of the attached documents with my complaint to your offices this coming week, as well as to the District Attorney and the San Diego Attorney General's office.

Agent Aguirre,

I have been waiting patiently since your last e-mail advising that all documentation had been forwarded to the public corruption investigation unit. Bell, Ca. is a small example of what has been going on between the Oceanside police & council, and the District Attorney Office for years.

I recently received the replies to public records request to the City of Oceanside and the San Diego County District Attorney's Office on several criminal complaints I filed regarding conspiracy and assaults by police to silence citizen protest, and false arrest and prosecution of innocent citizens while the OPD and the DA's office hide the evidence that proves they were innocent.

Once again there has never been any follow up or contact on any of the written documented complaints. All public record request are being rejected on false conditions, while ADA's and DDA's or quietly terminated, and declared to be personnel issues, to block criminal complaints and request for records on those complaints.

All contacts to the FBI north county office, offering assistance have been blocked and rejected at the same time the State AG is going after public corruption in Bell, CA., with far less corruption and documented violations of law, then the FBI already knows about in San Diego County.

Tomorrow night the Oceanside city council, that has been restructured by verified election tampering, conspiracy, fraud, assault, false prosecution & intimidation of citizens, is voting on that new police/fire contract with expanded pay and retirement benefits. The 3 to 2 majority the police /fire and their unions have criminally setup is expected to pass that new contract adding hundreds of millions of dollars in pay and benefits to a city budget that is already in deficit. At the same time the District Attorney's office is obstructing all complaints to protect their current finances and benefits, and future negotiations.

I expect the FBI to take appropriate action soon, or I will. I sent all that documentation to the FBI under signature of receipt for a reason.

Since 5-26-10, as requested, I have made 8 phone calls to the No. Co. FBI office indicated below requesting a meeting to discuss the documentation on public corruption involving multiple police officers, district attorneys, public officials, and their financial and political supporters. Following the 8th call I was finally contacted by an Agent Kelly. Agent Kelly advised the FBI did not want to meet with me or discuss the matter or the documentation, or if they even had all the documentation, and that if they needed anything they would contact me.

For more than a year, multiple Oceanside Police officers, Detectives, District Attorneys, and Public officials have been telling me exactly the same thing, while they suppressed all complaints, obstructed all investigations, and protected each other from criminal investigations and prosecutions. I truly hope that is not what I am hearing from the FBI.

I will wait and watch for a reasonable period of time to see appropriate legal action.
